A breief report

A expert talk "Raising Capital and Managing Finance for Startups" was organized for BCom II and IV Sem students on 25 April 2026 to gain practical insights into startup financing. The session was delivered by Mr. Sachin Biradar, Circle Based Officer, State Bank of India, Bijapur, and was attended by 59 students. The program began with a warm welcome address by Prof. Anusha Naikwad, who introduced the speaker and highlighted the importance of financial planning for startups.

During the lecture, Mr. Sachin Biradar explained how startups can raise capital through different sources such as bootstrapping, angel investors, venture capital, and bank loans. He emphasized that in the early stages, founders should focus on building a strong idea and validating their business model before approaching investors. He also shared real examples of startups that successfully raised funds and those that failed due to poor financial planning.
